## MEMORANDUM

**RE:** Traffic Count Report

The Village of Spencer requested traffic counting services from the North Central Wisconsin Regional Planning Commission for three locations within the Village. These locations are described in Table 1.

1	N Lasalle St	In between set of both RR Tracks	Thurs-Wed 5/15 - 5/21
2	Main St	East of RR Tracks and West of Wisconsin St.	Thurs-Wed 5/22 - 5/28
3	E Willow Dr	West of RR Tracks and East of S Monroe St.	Wed-Mon 6/4 - 6/9

The Village requested general information with regard to traffic volumes on these roads. The attached reports summarize the data from these sites. For each location, there is a vehicle volume report, with average hourly vehicle counts by lane direction and totals for the counting period, a combined speed report with totals combined for both directions by speed group and time, and a combined classification report with totals combined for both directions by type of vehicle and time.

On N Lasalle St., traffic averages about 1,350 vehicles per day. The majority of vehicles counted were cars and pick-ups with about 5.6% 2-axle/6 tire trucks and a small percentage of larger trucks. Average speed over the counting period was about 28 mph.

On Main St., traffic averages about 121 vehicles per day. The majority of vehicles counted were cars and pick-ups with about 11.4% 2-axle/6 tire trucks and a small percentage of larger trucks. Average speed over the counting period was about 17 mph.

On E Willow Dr., traffic averages about 1,459 vehicles per day. The majority of vehicles counted were cars and pick-ups with about 4.8% 2-axle/6 tire trucks, 2.7% <5-axle double and 2.5% 5-axle double. Average speed over the counting period was about 23 mph.
